1. FINES

That it be a Policy of Council that Council, pursuant to Section 246 of the *Local Government Act 1999* fix the following fees for the expiation of offences against By-Laws:

1.1 By-Law No 2 Moveable Signs

\$187.50 for any breach of the provisions applying to the display of a sign or banner which does not meet the design, construction, placement, appearance and restrictions criteria as required by Part 2 of the By-Law 2.

1.2 By-Law No 3 Roads

\$187.50 for any breach of the provisions applying to activities requiring permission of Council on any road, including but not limited to advertising, amplification, animals, camping, donations, fires, preaching, busking, removal of animals, and driving on formed surfaces as required by Part 2 and Part 3 of the By-Law 3.1.3

By-Law No 4 Local Government Land

\$187.50 for any breach of the provisions applying to activities requiring permission from Council on local government land, including but not limited to access to waters, advertising and signage, aircraft, alteration to local government land, amplification, animals, bees, camping, closed lands,

distribution, donations, fires, fireworks, flora, fauna, funerals and scattering ashes, model aircraft, golf, liquor, preaching, picking of fruit, public exhibitions, displays, toilets, smoking, selling, removing earth/rocks etc, weddings and working on vehicles as required by Part 2 and Part 3 of the Bylaw 4.

1.4 By-Law No 5 Dog Management

\$187.50 for any breach of the provisions applying to the management and control on dogs within the council area, including but not limited to dog prohibited areas, dog on lease areas, limit on dog numbers and dog faecesas required by Parts 2 and 3 of the By-Law 5.

2. REVIEW AND EVALUATION

The effectiveness of this Policy will be reviewed on a biennial basis.

The Chief Executive Officer will report to Council on the outcome of the evaluation and if relevant make recommendations for amendments, alteration or substitution of a new Policy.

The Policy will not be altered or substituted so as to affect a process already commenced.
