- 3. Based on the CEOs contract that the CEOs remuneration be adjusted by 6%, for the period ending June 2022. The Panel notes in this respect the CEO has received 0% adjustment for 2019/20 and 0% for 2020/21 year as acknowledgement of the COVID impacts and that staff over this same period have received a 1% for 2019/20, 2% for 2020/21 and 4.7% for 2021/22— totaling 7.7% adjustment.
