5 ITEMS LISTED FOR DISCUSSION

5.1 FEEDBACK FROM THE NATIONAL CLIMATE EMERGENCY SUMMIT

Jack Gill reported back on the Summit and thanked the Town of Gawler for supporting his participation. Some observations:

- The Summit covered scene settings, different elements, community engagement, language to use to encourage people
- Created opportunity to have lunch with Darebin council ask questions they discussed their progress to date
- Community engagement learning
 — designing a community who is better prepared,
 Gawler should be acting as a catalyst as we were first council to declare Climate
 Emergency
- Incorprated health based line to help disadvantaged, unwell, can access help
- Encouraged sustainability
- The Summit discussed the need for 'Lighthouse communities' and leading other councils Gawler can link in with Light, Barossa, Adelaide Plains. – There is a valuable role Gawler Council can play
- Some councils started pre 2010 didn't necessarily declare a climate emergency, started by decreasing emissions etc
- Different language can help engage the community
- There were not a lot of other SA councils present, Some may have switched to online attendence.

The Working Group expressed interest in making the links from presentations available.

5.2 PARTNERSHIPS AND FRAMEWORKS

Climate Change Sector Agreement with the South Australian Government & Jen St Jack

Jen St Jack serving as regional Regional Climate Partnerships Coordinator attended for this item

- Jen described the role of Climate Change Sector Agreements as providing focus and collaboration which can help support the implementation of action plans.
- They are described in the state Climate Change and Greenhouse Gas Emissions Reduction Act 2007 but are on binding
- Sector Agreements are flexible instruments allowing councils to choose what goes into the agreement
- Recent Sector Agreements have been made by Regional Climate Partnerships (11 across SA) such as Resilient East, Adapting Northern Adelaide and Resilient Hills and Costs
- These were set up in 2011 under state government Climate Adaptation initiative, with limited co-funding opportunities to develop climate adaptation plans and support coordinators. The Regional climate Partnerships enabled regions to get together with community and interested people to understand science at a regional level and develop plans and priorities
- The last Climate Action Plans were signed off in 2016 with many supported by Climate Change Sector Agreements to guide the implementation of the plans and meeting committments.
 - As Climate Change Sector Agreements are co-signed by Mayors, CEOs and ministers, they provide high level direction which assists in establishing Working Groups, seeking funding collaboration and establishing partnershops
- Operational funding has been met by the councils with grant funding via water

Sustainability Grants assisting in some cases.

- In this region, a Climate Chane Sector Agreement was signed between state government and RDA Barossa, focusing on sustainable agriculture and viticulture. In other regions, councils have been the primary participant. All of the regions who are working really well, collaborate really well
- The Working Group agreed that Barossa (Council and RDA), Light and Adelaide Plains were good potential partners and Gawler has the opportunity to act as a lighthouse having declared a Climate Emeerrgency.
- Jen St Jack Strongly encouraged the Town of Gawler to take regional approach. However, Tim was concerned that it may not be possible to progress a Sector Agreement for years if it required all partners to sign at the same time.
- Tim has drafted an example Climate Change Sector Agreement to discuss with other councils and stakeholders.
- Jen also advised that the State Government is currently reviewing its climate strategy and that there had already been some advocacy for a program of co-funding –for regional climate partnerships.

Cities Power Partnership

- The working Group noted that other SA councils in have joined this partnership and that there are direct and indirect benefits.
- The Working Group noted that there is no cost but a pledge is required, and agreed that
 the next step is to prepare a paper for Council describing why it is important for the Town
 of Gawler to join, particularly around the collaboration that could result in lower costs and
 legal certainty for accredited renewable electricity.

Climate Clever - Schools greenhouse tracking tool

- Tim informed the Working Group about a recent presentation on the Climate Clever schools program, which is based around an energy and greenhouse accounting software package and student and family education and awareness.
- Climate Clever was established in Westrern Australia and is now being proposed for South Australia through a trial offer to councils and schools.
- The cost for councils is \$850 per year, and for schools is between \$800 and \$6500 depending on school size.
- The tool is very user friendly, can provide access and some community emissions snd energy data to Council
- The program is not a replacement for Trellis which is based around data processing from billing and consumption information for council operations.
- The Working Group noted Climate Clever that families of students can access the program, and this would be one way for council to interact with community in the Climate Emergency.
- All members of the working group supported pursuing the Climate Clever schools program.

ACTIONS/RECCOMENDATIONS

Cities Power Partnership

- 4. The Working Group provided in-principle support to progress this initiative, The working group ageed with Cr Koch that a summary of the program and benefits be prepared in the first instance.

5.4 BUDGET BIDS AND CEWP WORKING GROUP INFLUENCE

Jack Darzanos provided an update of the Budget Process.

- A number of projects relating to Climate Change are currently below the approval line
- There is scope to strengthen a project bid that would encapsulate renewable electricity, centred projects through a feasibility study to develop a forward program.
- The working Group discussed how they can provide input across all bids. There were three elements:
 - 1. What are the budget bids in consideration for this year, looking at all bids
 - 2. Providing high level CEAP Working Group advice (best advice) for projects
 - 3. Communicating that the work to respond to the climate Emergency, is dependent on progress that is beyond the immediate budget for this project
- Kathryn discussed the structural barriers to new initiative CEAP projects which are not immedietly seen as important and cannot easily be communicated in brief tables. It is therefore important for the CEAP Working Group to ensure that additional succinct but necessary information is provided to decision makers.

ACTIONS/RECCOMMENDATIONS

5.3 TOWN OF GAWLER - BUSINESS ENTERPRISES AND COMMUNICATIONS AND GAWLER BUSINESS DEVELOPMENT GROUP (GBDG)

David Barrett, Manager Business Enterprises and Communications, attended this item to assist the Working Group in planning how best engage with the GBDG on addressing the impacts of climate change, business preparedness and opportunities.

- David explained the council's links to the GBDB and that we may wish to approach them directly or invite a representatibe to CEAP meetings as required.
- Cr Koch is a proxy to board also, Cr Sambell is the current member of the board
- Council is ery keen to support businesses and business growth in the Town of Gawler and would be happy to pass on relevant Climate and CEAP information onto board
- Face to face communication would be best to engage, and there is scope for presenting to the board at their monthly meetings held 3rd tues of each month 7:30am start)
- The working Group noted that the GBDG provides education and development programs for businesses. Explore the opportunities for a workshop component to include Building Upgrade Finance and other potentil items that can benefit businesses.

- Life Cycle Assessment including all depreciation and servicing costs is a way to inform procurement decisions and compare the Marginal Cost of [greenhouse] Abatement in option comparisons
- This can assist in communicating decisions with staff and communities
- Looking at light vehicles initially, potential to assess heavuy vehicles comparing electric vehicles with fossil fuel vehiclesl
