Mr Inat goes onto clarify "As part of this review process, Council will be undertaking a two phase consultation process. The preliminary phase will seek to gauge matters of importance within the local community as well as their thoughts about the existing Community Plan. This preliminary consultation period will commence on **Wednesday 29 April 2020 and conclude COB Friday 22 May 2020"**.

The information gathered through this initial consultation phase will assist Council with formulating a Draft Community Plan 2030+ which will then be the subject of further consultation (Stage 2). The second phase of public consultation will now be totally online. Although Council will no longer be conducting any public gatherings for the foreseeable future, we will still be available to discuss the community plan and answer any of your queries.
